23 1. I am the attorney of record in the foregoing chapter 13 bankruptcy case. I have
24 personal knowledge of the matters set forth in this declaration and if called to testify, could and
25 would testify competently thereto.

26 2. Due to the passage of the *Bankruptcy Abuse Prevention and Consumer Protection Act*
27 *of 2005* (hereinafter “BAPCPA”), the language in the current mandatory chapter 13 plan no longer
28 complies with the legal requirements under BAPCPA.

1 3. Chapter 13 Trustee Kathy A. Dockery has made available to bankruptcy practitioners
2 a recommended revised chapter 13 plan on her website. I have personally reviewed the
3 recommended revised chapter 13 plan (hereinafter “Revised Plan”), agree that the plan’s contents
4 complies with the legal requirements under BAPCPA and have filed a plan using the Chapter 13
5 Trustee’s revised plan.

6 4. In compliance with Local Bankruptcy Rule 3015-1(b)(4), I have attached the Chapter
7 13 Trustee’s red-lined version of the revised plan which specifies each deletion, addition and
8 revision to the current mandatory chapter 13 plan. Any deletion to the contents of the current
9 mandatory plan has been interlineated. Any addition to the contents of the current mandatory plan
10 has been italicized. A true and correct copy of the Chapter 13 Trustee’s red-lined revised chapter 13
11 plan is attached hereto and incorporated herein by reference as Exhibit “A”.

12 5. Any proposed modification to the contents of the revised plan has been set forth in
13 the miscellaneous provisions or paragraph VII(E) of the plan.

14 6. I have served a copy of the revised plan with this Declaration and its exhibits on all
15 parties in interest.
